



RESPONSIBILITY and LIABILITY WAIVER

I, _____, the undersigned student (or legal guardian on behalf of the student if under age 18), hereby acknowledge and agree to the following:

1. AGREEMENT OF PARTICIPATION

- 1.1 I will conduct myself in strict accordance with the Sol Camps Code of Conduct
- 1.2 I will take reasonable care of other and myself in Sol Camps and will not take any unreasonable risks that might endanger my, or another’s health or life.

2. ASSUMPTION OF RISKS

- 2.1 I understand I will be in unfamiliar surroundings and will be exposed to risks to my person and possessions.
- 2.2 I understand I may suffer physical injury, sickness or death or damage to my property as a result of my participation in the program and/or activities organized by Sol Camps
- 2.3 I understand that certain programs/activities at Sol Camps involves the use of facilities and services provided by third parties and which are out of control of Sol Camps
- 2.4. I freely and voluntarily accept and assume all such risks, dangers and hazards and understand that Sol Camps, despite its efforts, may not be able to ensure my complete safety at all times.

3. ASSUMPTION OF RESPONSIBILITY

- 3.1. I am medically fit and do not suffer any disabilities, physical limitations, or physical, emotional or psychological conditions, other than those disclosed on the Sol Camps Health Form
- 3.2. I understand that some of the Sol activities offered are sporting activities and/or activities which require a certain degree of skills and physical fitness and that participating in such activities exposes me to certain risks of accident or injury
- 3.3. I understand that medical insurance is required for the duration of enrolment at Sol Camps and I will purchase and maintain medical insurance coverage throughout the duration of my enrolment at Sol Camps either through Sol or my own insurance provider
- 3.4. I understand that the pictures and videos taken at Sol Camps may be used for promotional material

4. LIABILITY WAIVER

- 4.1 I release and hold harmless Sol Camps, its employees, students, agents and representatives from any and all liability for any loss, damage, injury or expense that I or my heirs, next of kin, executors, administrators, families or representatives may suffer as a result of my participation in Sol Camps activities due to any cause, including but not limited to accidents, negligence, breach of contract, acts of God, civil unrest, sickness, transportation, scheduling, government restrictions or regulations, and any expenses I may incur while participating in the activities
- 4.2. I understand this agreement cannot be modified except in writing by Sol Camps and that no oral modification or interpretation shall be valid
- 4.3. This Responsibility and Liability Waiver shall be effective and binding upon my heirs, next of kin, executors, administrators, families or representatives and assigns in the event of my death or incapacity

In the event of any misunderstanding or dispute regarding the interpretation of this Responsibility and Liability Waiver, the laws of the Province of Ontario shall be applied in determining its meaning and effect
